7.3.2022 End of year accounts 2019 / 20

End of year accounts 2019 / 2020 :

Public rights dates amended from original to allow for bank holiday days;

2019/20 was a difficult year for Council because of the effect of the Government imposed COVID lockdown and consequent inability to properly conduct its normal end of year processes in March/April. Whilst the AGAR was subsequently "approved at a meeting of the Council on 29/04/2021 agenda 29.04.2021/19 Clerked by LARALC and properly delivered to external auditors PKF Littlejohn, there is no record to show that the process for public scrutiny of the accounts "publishing a notice public rights for the required 30 days" was carried out, and because of that the accounts can't be closed until that process has been completed.

Given that background I am proposing that we approve conducting that process retrospectively, and move that members approve the publication of the document headed Asfordby Parish Council notice of public rights and publication of unaudited annual governance & accountability return for the year ended 31st March 2020 (included with this document) for thirty working days (6 weeks) from Friday 18st March until close of business on Wednesday 4th May 2022"
