### 10. Budget and Precept 2024/25.

To maintain services and ease the impact on Parish precept it is proposed to utilise any under spend in the 2023/24 tax year, together with the transfer of circa £50,000.00 from the Jubilee Park footpath reserve. Members are asked to consider and approve:
