MINUTES OF THE PARISH COUNCIL MEETING

Friday 22th December 2023, 7.00pm - Held at Asfordby Parish Office

22.12.23/1. To receive apologies for absence.

22.12.23/3. To approve and sign the minutes of previous meetings.

Minutes of the Parish Council Meeting held on 26.10.2023 were approved by all and signed as an accurate record of the meeting.

22.12.23/4. Chairman's report.

The Chairman reported that the Council had been engaged in a number of interesting projects on behalf of the Parish since the last meeting, which he wished to bring to the notice of the public.

- 1. The Chair reported the long fought for Parish NHP has finally achieved status with Melton Borough Council, and could now be used to influence decisions regarding planning applications.
- 2. The Chair reported the Parish orchard for the Queens Green Canopy initiative, comprising of a number of mixed fruit trees had been planted in Jubilee Park with the help of the Guides, Brownies, Councillors & members of the public.
- 3. The Chair reported the new Christmas tree light switch on, led by Father Mark was well attended a great success.
- 4. The Chair reported the long awaited Parish Council Facebook group is now up and running, and it is our hope that many people will join it to participate and share important information about issues in the Parish.
- 5. The Chair spoke on the Melton Local Plan consultation being run by Melton Borough Council from 6th November to the 7th January, and expressed disappointment that the Asfordby ward councillors had not contacted the parish council to advise on the consultation.

6. The Chair said that due to the public forum having being repeatedly abused by some members of the public attempting to introduce new subjects, which was disrupting the progress of the essential business of Council, which needed completing. It was his prerogative to ensure the smooth running of the meeting, and tonight it would be removed from the early part of the agenda. Parishioners would now be able to raise any matters of concern in writing up to midday on the day preceding the meeting. Space will in future be provided for public input on non- agenda items after the main business is concluded, subject to the rules.

22.12.23/6. Grant to Local Group.

Members authorised an S137 payment for the sum of £299.34 to the Friends of Asfordby Garden and Wildlife Group.

Members received the estimated year-end financial statement and draft 2024/25 budget proposal, and were asked to note the considerable increase in the costs of all brought in professional services and specifically water, electricity and gas. It was further noted that LRALC had increased their charges in excess of 60% Members were asked to approve the use of funds as outlined below to reduce the precept requirement and impact on local taxation.

- a. The transfer of any surplus from the 2023/24 budget, estimated figure £9,922.83.
- b. The expected self-generated income for 2024/25 estimated £23,016.25.
- The transfer of £44,611.32 from the Jubilee park footpath reserve.
 Estimated total provision from local generated income and reserves is £77,550.40.
